- **Technology and Systems:** Implementing and managing library databases, digital platforms, and information management systems.
- **Budget and Staff Management:** Overseeing library budgets, managing resources, and supervising library staff.
- Collection Development: Identifying and purchasing new materials and digital subscriptions to meet user needs.
